#### **Action Item(s) To Be Reported**

#### **1. RECOGNIZING NATIONAL POPPY DAY – MAY 24, 2019**

WHEREAS, May 24, 2019 marks the observation of National Poppy Day in Livingston County; and  
WHEREAS, at the end of World War I, the American Legion adopted the poppy as a symbol of freedom and the blood sacrificed by troops in wartimes with poppies serving as a symbolic tribute to our fallen and the future of living veterans and service members; and

WHEREAS, the use of the poppy symbolically comes from the poem In Flanders Fields, which movingly begins, "In Flanders Fields the poppies blow, between the crosses, row on row," referring to the poppies that sprang up in the churned earth of battlefields across Belgium and France where soldiers died fighting; and

WHEREAS, The American Legion Family has long utilized the red poppy as its official flower and it is fitting that as the American Legion and American Legion Auxiliary approach their 100<sup>th</sup> anniversaries, they expand the meaning and symbolism of the poppy, mirroring the manner in which the poppy is symbolically showcased in England and Canada in celebratory fashion on their Remembrance Day, also known as Armistice Day and Poppy Day; and

WHEREAS, wearing a poppy will unite citizens from across the country who decide to show their patriotism; and

RESOLVED, in recognizing the importance of honoring all those from Livingston County who served in battle and on the home front, the Livingston County Board of Supervisors hereby proclaims May 24, 2019 as "National Poppy Day" encouraging all citizens, residents, and visitors of Livingston County to join in observing this day to honor every service member who has died in the name of liberty, freedom and democracy while also showing their support for living veterans, service members, and their families.

1. U.S. DEPARTMENT OF VETERANS AFFAIRS (VA) UPDATES & CONSIDERATIONS ON VIETNAM VETERANS: According to testimony given before the Senate Veterans Affairs Committee by the VA's Dr. Richard Stone, the four conditions that the VA are considering to add to the presumptive list of Agent Orange exposure are bladder cancer, hypothyroidism, hypertension, and Parkinson's-like symptoms. The National Academies of Science, Engineering and Medicine linked hypertension to Agent Orange exposure in November 2018. However, all of these conditions (especially hypertension) are rather commonplace in older adults, even if without facing exposure to Agent Orange. The VA therefore must decide whether the prevalence of these conditions among older individuals who were exposed to Agent Orange is significantly higher than the prevalence of these conditions among non-exposed older individuals. The VA set a "soft deadline" of 90 days to make a decision regarding these four conditions.



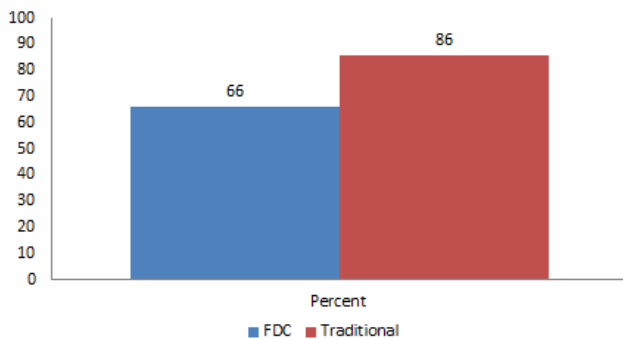

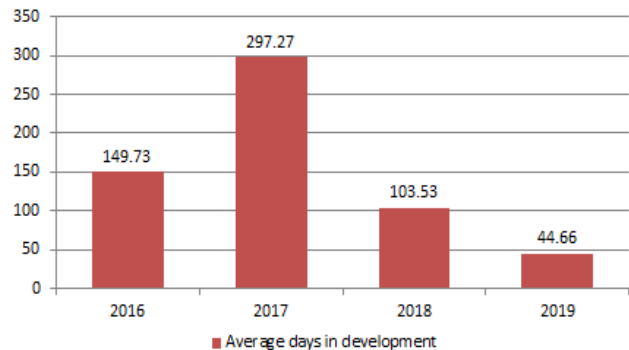
Additionally, VA Secretary Wilkie recommended that the U.S. Department of Justice (USDOJ) refrain from appealing the Federal Court Circuit decision that finally extended the presumption of Agent Orange exposure to Blue Water Navy Veterans. This means that the VA has conceded the accuracy of this decision. Unless the USDOJ decides to contradict the VA's decision, the Federal Circuit's holding will stand as valid law, securing the ability of Blue Water Navy Veterans to be granted the same legal presumptions as all other in-county Vietnam Veterans.

2. **SUICIDE PREVENTION AND MORAL INJURY CONVERSATIONS UPDATE:** The April 19, 2019 event at Camp Stella Maris was very successful. The open discussion on suicide prevention with Dr. Marek Kopacz, M.D., Ph.D. sponsored by Veteran Services and the Livingston County Suicide Prevention Task Force had 50 participants.
3. **FULLY DEVELOPED CLAIMS (FDC) VS TRADITIONAL CLAIMS:** Over a 3 year span review, veterans who filed an FDC claim are less likely to have a favorable outcome. Nearly 50% do not follow up and provide the information needed for their fully developed claim and mandate their claim to be withdrawn from the VA system. Having a veteran file a traditional claim allows the Veteran Service Officer to prepare for one of the three lanes for appeals. The court finds in favor of the veteran 77.4% of the time through the appeal process. It has been previous practice for our office to properly create FDC claims, but as Veteran Affairs practices and protocol have changed, so has the practice of our office to have veterans complete a traditional claim as fast as possible. The change in process from FDC to Traditional Claims is more favorable for the veteran's outcome.

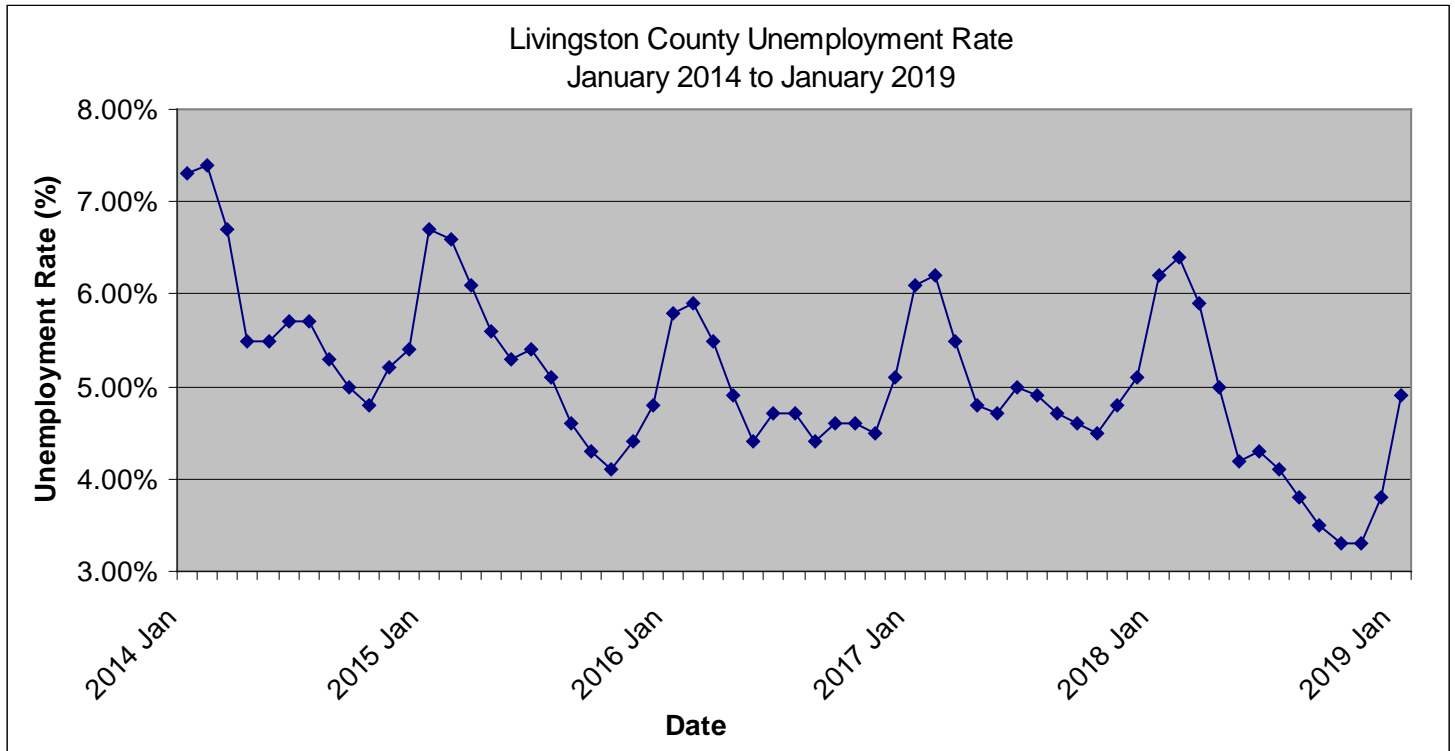
