2. PROCLAIMING WORLD BREASTFEEDING WEEK 2022, AUGUST 1-7, 2022

WHEREAS, the health and well-being of Livingston County residents are of utmost importance to the prosperity and livelihood of our local communities; and

WHEREAS, the United States Breastfeeding Committee declared August National Breastfeeding Month, and the World Alliance for Breastfeeding Action declared August 1-7 as World Breastfeeding Week to promote breastfeeding as a key to sustainable development; and

WHEREAS, the Livingston County Department of Health and community partners are coordinating a World Breastfeeding Week event on August 6 from 10:00 am-1:00 pm at Highland Park in Geneseo; and

WHEREAS, exclusively breastfeeding infants for the first six months after birth with continued breastfeeding for at least twelve months ensures that both mothers and infants receive maximum health benefits; and

WHEREAS, breast milk is physiologically tailored to meet the needs of infants' maturing digestive systems, which ensures proper growth and development, helps prevent a variety of acute and chronic diseases, reduces childhood obesity, and improves a child's neurodevelopment; and

WHEREAS, breastfeeding provides women with health benefits such as reduced risk of ovarian, uterine, and breast cancer, osteoporosis, and high blood pressure; and

WHEREAS, breastfeeding enriches the bond between a mother and her baby; and

WHEREAS, comprehensive lactation support programs increase employee retention rates, decrease absenteeism, decrease health care costs, improve employee productivity, and support family-friendly communities; and

WHEREAS, all Livingston County employers are encouraged to accommodate the breastfeeding needs of mothers and their children; and

WHEREAS, as of March 23, 2010 Section 7 of the Fair Labor Standards Act (FLSA) (P.L.111-148); Employers are required to provide "reasonable break time for an employee to express breast milk for her nursing child for 1 year after the child's birth each time such employee has need to express the milk" in addition to providing "a place, other than a bathroom, that is shielded from view and free from intrusion from coworkers and the public, which may be used by an employee to express breast milk."; and

WHEREAS, keeping breastfeeding high on the public health agenda is critical in improving the health and well-being of mothers and babies; now, therefore, be it

RESOLVED, that the Livingston County Board of Supervisors supports the World Breastfeeding Week 2022 and the Livingston County Department of Health in their efforts, and commands all who participate in such a worthy cause, and proclaims the first week in the month of August, as World Breastfeeding Week 2022.

- 1) Hospice served 36 individuals in May, with two (2) at Noyes hospital and nine (9) at the CNR. We had 18 referrals and admitted 22 people in May.
- 2) Staff is working diligently with participants on the formula shortage crisis. We recently sent a letter to all health care providers in the areas we serve, encouraging them to refer any patients struggling with access to formula or needing breastfeeding support to their local WIC office. WIC offices normally never have formula on site; however, we have received two small 'drop shipments' of formula from the state to help participants with access to formula. Staff have been bringing small amounts of formula, sent to us by the state, to participants in need. The two most difficult formulas for our participants to find right now is Enfamil Gentlease and a costly hypoallergenic formula prescribed to babies called Nutramigen. NYS WIC has recently allowed for flexibilities in alternative formula sizes, brands, and stores brands to be purchased by participants with their eWIC card and stated they will continue to expand these flexibilities. We have been updating participants individually with updated formula resources and alternatives. The Abbot formula factory in Sturgis, Michigan recently reopened; we are hoping to see the effects of this reopening in the coming weeks.
- 3) WIC should be hearing soon if the Public Health Emergency due to expire mid-July 2022, will be extended. If the Public Health Emergency is extended again, our remote services will be extended to January 2023 as we have 60 days to return to clinic after the public health emergency expires. We are currently providing remote services until at least mid-October 2022.
- 4) The federal WIC income guidelines have been updated and started in effect 6/1/22 and will continue to be in effect until June 2023. WIC looks at the 185% of the poverty level for income guidelines. For an example, in 2022 the federal WIC income guidelines were set at \$23,828 annually or \$459 weekly for a household of one. The updated guidelines are now set at \$25,142 annually or \$484 weekly for a household of one.
- 5) 22 food inspections resulted in 16 non critical violations. Food staff also has been prepping for the upcoming "festival season". Many temp food vendors have been contacting the EH office for paperwork and questions about the permitting process.
- 6) The final two campgrounds have received their preoperational inspections. Pools and beaches are prepping to open as well and sanitarians have conducted six (6) preoperational inspections (5 pools, 1 beach).
- 7) Affordable Great Locations have sold their 11 Mobile Home Parks to a new property management group. Eight parks have been inspected as a result.
- 8) The rabies program investigated 23 animal bite reports and had 3 animal specimens (2 bats, 1 cat) sent for rabies testing with none testing positive for the virus. 1 post exposure treatment was approved. With the change to warmer weather we should expect an increase of calls for folks experiencing bats in their homes..
- 9) Dog Control took in 24 dogs in May (year-to-date - 77).
- 10) Five (5) COVID clinics held in May: four (4) held inside with 36 participants and one (1) drive thru held with 56 participants.
- 11) Medical Reserve Corp - 216 volunteers are down to 85, due to living in another county, no longer want to volunteer in Livingston, no longer interested without Pandemic, moved to other area, and illnesses.
- 12) Number of immunization clinics – five (5), with 92 participants.
- 13) Regional transportation position approved in Genesee/Orleans Counties – Reviewing contract with County Attorney.
- 14) 22 lead cases in May.
- 15) Mental Health had 71 intakes: 1,114 Visits in May.

- 3) Nurse Recruitment – The CNR is actively recruiting qualified applicants.

- b) There are currently 6 Full Time Day shift RN, 2 Full Time and 1 Part Time Evening Shift RN, & 1 Full Time Night Shift RN vacancies.
- c) There are currently 10 Part Time Day Shift, & 9 Part Time Evening Shift PCA vacancies.
- d) There are currently 3 Part Time Day Shift and 2 Part Time Evening Shift Uncertified Nursing Assistant vacancies.
- 4) Beacon Solutions Monthly Report – to be distributed.
- 5) The Governor issued an updated [Executive Order](#), 4.7, related to the Statewide Disaster Emergency Due to Healthcare Staffing Shortages in the State of New York. While the EO extends other staffing flexibilities, it explicitly ends the suspensions of penalties for failure to meet the nursing home minimum staffing levels and for failure to meet the requirement that nursing homes spend 70 percent of revenue on direct resident care and 40 percent of revenue on resident-facing staffing. These mandates are in effect as of, April 1st.
- 6) Emergency Declaration Blanket Waivers (1135) For Various Provider-Types Ending 60 Days from Publication of this Memorandum: Ending June 6, 2022.
-Training and Certification of Nurse Aides for SNF/NFs - 42 CFR §483.35(d) (Modification and Conditional Termination). CMS waived the requirements which require that a SNF and NF may not employ anyone for longer than four months unless they met the training and certification requirements under §483.35(d). CMS previously provided information related to Page 5 of 6 nurse aides working under this blanket waiver in CMS memorandum QSO-21-17- NH. This memo provides additional information as well on the modification of this waiver below. We remind states that all nurse aides, including those hired under the above blanket waiver at 42 CFR §483.35(d), must complete a state approved Nurse Aide Competency Evaluation Program (NATCEP) to become a certified nurse aide. State approved NATCEPs must have a curriculum that includes training in the areas defined at 42 CFR §483.152(b), such as respecting residents' rights, basic nursing skills, personal care skills, and caring of cognitively impaired residents. Additionally, the requirements at 42 CFR §483.154(b)(i) and (ii) requires these nurse aides pass a written or oral exam, and demonstrate skills learned. Lastly, we note that CMS did not waive the requirement that the individual employed as a nurse aide be competent to provide nursing and nursing related services at 42 CFR §483.35(d)(1)(i), and that requirement must continue to be met.
- 7) Staff Vaccination status per CMS- expects all providers' and suppliers' staff to have received the appropriate number of doses by the timeframes specified in the QSO-22-07 unless exempted as required by law, or delayed as recommended by CDC. Facility staff vaccination rates under 100% constitute noncompliance under the rule. Non-compliance does not necessarily lead to termination, and facilities will generally be given opportunities to return to compliance.
- 8) On May 17, 2022 the CNR was approved by the NYSDOH to implement a Temporary Nurse Aide (TNA) to CNA Training Program at our facility. The CNR currently has 9 individuals' in the TNA program.
- 9) On June 14, 2022, Governor Hochul issued Executive order No. 11.6, continuing the "Declaring a Disaster Emergency in the State of New York" through July 14, 2022.
- 10) COVID-19 Vaccination Booster Clinic - The Center continues to facilitate weekly booster clinics, as needed, with the Center's contracted pharmacy for the eligible Residents / Patients and Employees. Vaccination boosters are offered and available to residents and staff on weekly basis. As of 06/27/22 *The resident vaccination acceptance rate is 99.3 The first booster rate is 95.1% and second booster rate is 70.1%. The current staff number that are fully vaccinated is 99.4% and the booster rate is 63.1%.*
- 11) The CNR was notified by CMS in early May that the facility has achieved an overall rating of 4 STARS on the CMS website Care Compare. This includes a 4 STAR rating for the health inspection, 4 STARS for the staffing rating, and 3 STARS for quality measures.
- 12) Director of LTC Justin Bayliss assumed the role of Administrator of Record effective June 13, 2022.
- 13) Garden of Life (G.O.L.) Adult Day Health Care Program – The program remains suspended at this time.
- 14) NYS-DOH reporting continues via the HERDS survey in the Health Commerce System. Reporting has been reduced to 5 days per week (M-F).
- 15) The CNR reports survey data to the CDC, via the National Healthcare Safety Network, twice per week.

- 16) The CNR initiated reporting weekly vaccination data to the CDC, via the National Healthcare Safety Network.
- 17) The Center continues to communicate with Residents / Families weekly via telephone calls, electronic communication(s) and letters.
- 18) Dialysis Extension Clinic (D.E.C.): The Dialysis Extension Clinic is currently open Mon-Wed-Fri, on Day and Evening shifts. WCHS is currently recruiting for additional staff in order to increase volume and open the clinic Tue-Thur-Sat.
- 19) During the weekly generator inspection, it was noted that a significant amount of smoke was coming from the exhaust stack. The smoke was excessive enough to have concerns over the possibility of entrance into the resident rooms above, as well as a substantial risk for failure. Due to regulations, the LCCNR had to procure a temporary generator. The LCCNR received that generator on June 25th 2022. The primary generator will be inspected for repair needs on July 5th 2022.
- 20) The LCCNR received scheduled Diversity training on June 27th 2022 through June 28th 2022. All staff within the LCCNR from all departments were requested to attend. The training was offered in 1-hour increments. Areas of discussion included age, race, religion, etc. with a focus on opening up to having an understanding of others and their way of life.
- 21) Operational Assessment & Plan:
 - a) Admissions & Turnover: Marketing efforts have been initiated with Rochester Regional, WCCH, & Noyes Memorial in Dansville with contacts established. Conversation / approach to care initiated with in-house medical group. Focus will be on establishing parameters for admissions in order to reduce acceptance time; likely increasing acceptance from those individuals' looking for a rehab bed. Also looking at a "treat in place" type of approach to medical care with less hospitalizations / ER utilization.
 - b) Case-Mix Index (CMI): Last CMI was .86 (Oct. 1, 2021 – Mar. 31, 2021) and will directly impact the July 1st through December 31st 2022 Medicaid rate. Current CMI runs from April 1st 2022 through September 30th 2022 and will directly impact the Jan. 1st 2023 – June 30th 2023 Medicaid rate. Current CMI for that timeframe is .86. LCCNR has a 3-month timeframe to increase the facility CMI and ultimately the Medicaid rate for Jan. 1st of 2023. Discussions & approach to CMI have begun with the LCCNR MDS staff to focus on that time frame. Goal of obtaining a .95 for the time period established. The impact of that increase would result in approximately an additional \$9.00 per resident per day for a 6-month period. Based on facility census, that would result in an increase of \$230k for a 6-month period with no changes to the current census. Those figures will increase substantially as census increases and CMI target increases.
 - c) Quality Metrics: The facility is rated on Short-Term Quality Measures & Long-Term Quality Measures. The facilities ratings in both areas are 3 STARS on the CMS Care Compare website. LCCNR had a short-time frame to address 2nd quarter data as it comes to an end on June 30th 2022. A 100% in-house review of the residents including all of those that were triggering for quality measures. Assessments for those triggers that could be removed were scheduled. Meeting was scheduled with the QA nurse, MDS Staff, DON, Deputy Director, & the Director that included education on the QA process and rating system for Quality Measures (QM). Focus will be on standardizing processes to ensure maximal positive outcomes with QM's that will also drive the quality of resident care. LCCNR overall goal is to achieve 5-STARs for Short-Term & Long-Term QM's. Timeframe to achieve 5-STARs in the identified areas is 5 quarters.
 - d) Accounts: Focus on identifying an interdisciplinary team that will meet monthly to review 100% of in-house accounts. This process will be established to ensure continuous procurement of funds and to aid the LCCNR in taking the correct steps to meet its financial obligations.
 - e) Policies: Discussion has taken place to move to an electronic policy format. This would include a 100% review of LCCNR policies.
