10:15 VETERAN’S SERVICES AGENCY – DAVID TERRY

Action Item(s) To Be Reported

SUPPORTING OPERATION GREEN LIGHT FOR ACTIVE MILITARY SERVICE MEMBERS IN TRANSITION TO CIVILIAN LIFE (VETERAN STATUS)

WHEREAS, approximately 200,000 service members transition to civilian communities annually and there is expected to be an estimated 20% increase in service members that will be transitioning to civilian life in the near future; and

WHEREAS, studies indicate that 44% - 72% of service members experience high levels of stress during transition from military to civilian life. Sadly, active military service members transitioning from military service are at a high risk for suicide during their first year after military service; and

WHEREAS, the Livingston County Board of Supervisors appreciates the sacrifices our United States military personnel make while defending freedom and believes specific recognition should be accorded them in appreciation of their service; now, therefore, be it

RESOLVED, that the Livingston County Board of Supervisors hereby declares Livingston County a Green Light for Military Service County from October 12, 2022, through November 13, 2022. This is a time to salute and honor our men and women in uniform making the transition from active service to civilian life by switching one lightbulb to green to show visible support for veterans; and be it further

RESOLVED, that as a Green Light for Military Service County, the Livingston County Board of Supervisors hereby pledges to support the Expiration Term of Service Peer Mentorship Program (ETS-SP) that connects mentors to new veteran residents; and be it further

RESOLVED, that in observance of Operation Green Light for Military Service, the Livingston County Board of Supervisors encourages its citizens to recognize the importance of honoring all those who made immeasurable sacrifices to help to preserve freedom by displaying a green light in a window of their place of business or residence. Green is the color of hope, renewal and well-being. The simple action of changing one light to green can spark meaningful conversation regarding the recognition of veterans and help “green light” them forward as valued members of our communities.

- The Livingston County PFC Joseph P. Dwyer and Veteran’s Outdoor Rx Programs have officially started. September 14, 2022 the office had an official meet-and-greet with veterans at Al Lorenz Park introducing them to Bob Wolter, the Veteran One-Stop Center of Western New York (VOCWNY) Livingston County Peer Support Specialist. The event was successful with engaging conversation and the opportunity to share our vision and future plans. Afterwards we traveled to the American Legion county meeting with information sharing and introductions to representatives of all posts present.
- Our first scheduled event was a veteran raft fishing trip scheduled at Letchworth State Park with Adventure Calls Outfitters on September 24, 2022. A dozen veterans were scheduled to attend but due to recent rainfall and rising water levels the event had to be cancelled. However, the resiliency of veterans was that they still wanted to get together. Five veterans in total gathered at the Region Eight New York State Department of Environmental Conservation Headquarters fishing their ponds on the recognized day where a New York State fishing license was not required and ended the afternoon with an impromptu lunch at Tom Wahls in Avon.
- On September 20, 2022 Director Terry was present at the New York State Association of Counties 2022 Fall Seminar in Buffalo where panelists discussed among the veteran services group of state benefits and how counties are putting their PFC Joseph P. Dwyer funds into action.

- The Veteran One-Stop Center of Western New York (VOCWNY) has been awarded \$750,000 for the Staff Sergeant Parker Gordon Fox Suicide Prevention Grant Program (SSG Fox SPGP) with the purpose of reducing veteran suicide by expanding suicide prevention programs for veterans through the award of suicide prevention services grants to eligible entities to provide or coordinate the provision of suicide prevention services to eligible individuals and their families. Suicide prevention services covered by this part are those services that address the needs of eligible individuals and their families and are necessary for improving the mental health status and wellbeing and reducing the suicide risk of eligible individuals and their families. The VOCWNY will cover several counties including Livingston with services.

1. PROCLAIMING THE MONTH OF OCTOBER 2022 AS BREAST CANCER AWARENESS MONTH IN LIVINGSTON COUNTY

WHEREAS, breast cancer is the most commonly diagnosed form of cancer for women in the United States and remains the second leading cause of cancer death among American women; and

WHEREAS, mammography, an “x-ray of the breast”, is recognized as the single most effective method of detecting breast changes long before physical symptoms can be seen or felt. Early detection and improved treatment is believed to have significantly reduced the number of deaths caused by breast cancer; and

WHEREAS, researchers, scientists and numerous nonprofit organizations are dedicated to discovering the cure for breast cancer. During the month of October, we acknowledge the extraordinary commitment and effort invested in this cause; and

WHEREAS, we recognize that over two and a half million Americans are breast cancer survivors which gives us hope of a better future; now, therefore, be it

RESOLVED, that the Livingston County Board of Supervisors hereby extends its support to those who continue to cope with breast cancer, as well as to survivors and those advocating for prevention and a cure, and in so doing hereby proclaims October 2022 as “Breast Cancer Awareness Month” in Livingston County.

2. PROCLAIMING OCTOBER 2-8, 2022 AS MENTAL ILLNESS AWARENESS WEEK IN LIVINGSTON COUNTY

WHEREAS, mental health is part of overall health; and

WHEREAS, one in five adults experience a mental health problem in any given year; and

WHEREAS, approximately one-half of chronic mental illness begins by the age of 14 and three-quarters by the age of 24; and

WHEREAS, suicide is the tenth leading cause of death in the United States and the second leading cause among young adults and according to interviews with family, friends and medical professionals 90% of people who die by suicide have shown symptoms of a mental health condition; and

WHEREAS, long delays, sometimes decades, often occur between the time symptoms first appear and when individuals actually seek help. Early identification and treatment can make a difference in successful management of mental illness and recovery; and

WHEREAS, it is important to maintain mental health and learn the symptoms of mental illness in order to get help when it is needed; and

WHEREAS, every citizen and community can make a difference in helping end the silence and stigma that for too long has surrounded mental illness and discouraged people from getting help; and

WHEREAS, public education and civic activities can encourage mental health treatment and help improve the lives of individuals and families affected by mental illness; now, therefore be it

RESOLVED, that the Livingston County Board of Supervisors hereby proclaims October 2 – 8, 2022 as Mental Illness Awareness Week in Livingston County in order to shine a light on mental illness, fight stigma, provide support, educate the public, and advocate for equal care.

3. PROCLAIMING OCTOBER 23-29, 2022 AS NATIONAL LEAD POISONING PREVENTION WEEK IN LIVINGSTON COUNTY

WHEREAS, lead exposure to children can occur from a multitude of sources and can cause irreversible and life-long health effects; and

WHEREAS, lead is especially dangerous to children under the age of 6; and

WHEREAS, lead poisoning is preventable. The key is to keep children from coming into contact with lead. There are also simple steps that can be taken to protect all family members from lead based-paint hazards in the home; and

WHEREAS, education and awareness about the dangers of lead can help protect the lives of children living in Livingston County; now, therefore, be it

RESOLVED that the Livingston County Board of Supervisor's hereby proclaims October 23-29, 2022, as National Lead Poisoning Prevention Week. Residents and local government officials shall observe this week with appropriate programs and activities designed to enhance public awareness of lead poisoning prevention and the ways children and families can be protected from lead poisoning.

Informational Item(s) Written Only

- Focus is on Covid bivalent booster vaccination clinics; we are still only offering individual immunization appointments.
- Mental Health Tech upgrades including new laptops, monitors, telehealth equipment, conference room upgrades, have been ordered/received – waiting for IT to set up new equipment.
- Working with CASA and community on program ideas for opioid funding, CASA to present proposal – probable start in 2023.
- Working on Suicide Prevention media campaign. Working with Halley Torres (County Admin Fellow).
- Established new “Therapist Trainee” position due to enforcement of licensure regulations.
- 37 food service establishment site visits resulted in 39 non critical and 4 critical violations. 5 temp food operations were inspected. Out of 25 permitted facilities, only 1 was delinquent with their permit renewals.
- The rabies program investigated 30 animal bite reports and had 7 animal specimens sent for rabies testing with zero testing positive for the virus. Eight post exposure treatments were approved. One rabies clinic was held and saw about 200 serviced in two hours.
- EH staff assisted the NYSDEC with a complaint for an effluent discharge to a creek coming from Kraft in Avon. (The DEC has taken over the complaint).
- Septic system permit data shows there are about 20 fewer repairs through August of 2022 compared to both the 2020 and 2021 numbers. The local septic industry saw a dramatic increase in activity during the pandemic. This data may be interpreted as additional proof of a “return to normal”.
- SUNY CSHW (Center for Sexual Health and Wellness) clinics have resumed.
- Received an additional funding award letter from NYSDOH to increase and extend your Comprehensive Family Planning Program (CFPP2) contract for the period of 01/01/2022 - 12/31/2026. The annual award will be \$405,405, which is a huge relief, as clinic was running at a deficit. The previous annual award was around \$265,000
- In August, Hospice served 34 individuals; three (3) at Teresa House and one (1) at Suzanne's Place in Perry, five (5) CNR patients and the remainder were in their homes.
- Hospice “Celebration of Remembrance” was held on Thursday, September 15.

- 2) Current FT Nursing Assistant vacancies as of 08/29/2022 are: Night Shift 17, Evening Shift 27, Day Shift 37
- 3) Nurse Recruitment – The CNR is actively recruiting qualified applicants.
 - a) There are currently 5 Full Time Day and 2 Part Time Day Shift LPN, 10 Full Time and 3 Part Time Evening shift LPN and 6 Full Time and 3 Part Time LPN Night Shift vacancies.
 - b) There are currently 6 Full Time Day shift RN, 2 Full Time and 1 Part Time Evening Shift RN, & 1 Full Time Night Shift RN vacancies.
 - c) There are currently 11 Part Time Day Shift, & 13 Part Time Evening Shift PCA vacancies.
 - d) There are currently 0 Part Time Day Shift and 0 Part Time Evening Shift Uncertified Nursing Assistant vacancies. (UNA positions end Oct 5, 2022 per NYSDOH regulation).
- 4) Emergency Declaration Blanket Waivers (1135) For Various Provider-Types Ending 60 Days from Publication of this Memorandum: Ending June 6, 2022.
 - Training and Certification of Nurse Aides for SNF/NFs - 42 CFR §483.35(d) (Modification and Conditional Termination). CMS waived the requirements which require that a SNF and NF may not employ anyone for longer than four months unless they met the training and certification requirements under §483.35(d). CMS previously provided information related to Page 5 of 6 nurse aides working under this blanket waiver in CMS memorandum QSO-21-17- NH. This memo provides additional information as well on the modification of this waiver below. We remind states that all nurse aides, including those hired under the above blanket waiver at 42 CFR §483.35(d), must complete a state approved Nurse Aide Competency Evaluation Program (NATCEP) to become a certified nurse aide. State approved NATCEPs must have a curriculum that includes training in the areas defined at 42 CFR §483.152(b), such as respecting residents' rights, basic nursing skills, personal care skills, and caring of cognitively impaired residents. Additionally,

the requirements at 42 CFR §483.154(b)(i) and (ii) requires these nurse aides pass a written or oral exam, and demonstrate skills learned. Lastly, we note that CMS did not waive the requirement that the individual employed as a nurse aide be competent to provide nursing and nursing related services at 42 CFR §483.35(d)(1)(i), and that requirement must continue to be met.

- 5) On May 17, 2022 the CNR was approved by the NYSDOH to implement a Temporary Nurse Aide (TNA) to CNA Training Program at our facility. The CNR had 9 individuals in the TNA program. 5 passed the CNA certification test, 3 are retaking the test, 1 individual dropped out of program. TNA/UNA will no longer be able to work in SNF after Oct 5, 2022
- 6) Staff Vaccination status per CMS- expects all providers' and suppliers' staff to have received the appropriate number of doses by the timeframes specified in the QSO-22-07 unless exempted as required by law, or delayed as recommended by CDC. Facility staff vaccination rates under 100% constitute noncompliance under the rule. Non-compliance does not necessarily lead to termination, and facilities will generally be given opportunities to return to compliance.
- 7) On August 28, 2022, Governor Hochul issued Executive order No. 4.12, continuing the "Declaring a Disaster Emergency in the State of New York" through September 27, 2022. It is anticipated to be renewed by the end of September.
- 8) COVID-19 Vaccination Booster Clinic - The Center continues to facilitate weekly booster clinics, as needed, with the Center's contracted pharmacy for the eligible Residents / Patients and Employees. The COVID- 19 Bivalent Vaccination will be offered on September 27, 2022 at the CNR. Vaccination boosters are offered and available to residents and staff on weekly basis. As of 09/26/22 *The resident vaccination acceptance rate is 98.4 The first booster rate is 89.7%. The current staff number that are fully vaccinated is 99.3% and the booster rate is 64.4%.*
- 9) Garden of Life (G.O.L.) Adult Day Health Care Program – The program remains suspended at this time. Potential programs for the G.O.L. space is being assessed. They include reopening of G.O.L., or a potential child care service that could be beneficial in the recruitment of staff to the CNR. A needs-based survey has been completed and is currently being analyzed.
- 10) NYS-DOH reporting continues via the HERDS survey in the Health Commerce System. Reporting has been reduced to 5 days per week (M-F).
- 11) The CNR reports survey data to the CDC, via the National Healthcare Safety Network, twice per week.
- 12) The CNR initiated reporting weekly vaccination data to the CDC, via the National Healthcare Safety Network.
- 13) The Center continues to communicate with Residents / Families weekly via telephone calls, electronic communication(s) and letters. The focus of this communication has surrounded positive COVID reporting as well as visitation policy.
- 14) Dialysis Extension Clinic (D.E.C.): The Dialysis Extension Clinic is currently open Mon-Wed-Fri, on Day and Evening shifts. WCCHS is currently recruiting for additional staff in order to increase volume and open the clinic on October 17, 2022 for the Tue-Thur-Sat schedule.
- 15) The LCCNR lost back up emergency power to the fire pump due to transfer switch controller malfunction on August 3. LCCNR staff were on fire watch from August 3rd through August 26th, 2022. Fire Watch will be reinstated if facility goes on generator power. NYSDOH Principal Sanitarian notified. Parts for repair are on backorder for 12 weeks.
- 16) Agency nursing contracts being renegotiated at this time.
- 17) Insurance Contracts in contract phase include: Independent Health, WellCare. Aetna, United Health Care and Elderplan contracts are in rate negotiation prior to final contract submission.
- 18) Flexible scheduling is being investigated and survey is being completed with LCCNR staff.
- 19) Job Fair at the LCCNR was coordinated with the assistance of HR Dept and ITS Dept on September 20th was a success. We had 9 applicants. 7 applicants were hired (5 PCA's, 1 per diem CNA, and 1 PT RN) The LCCNR is planning another Job Fair for end of October.
- 20) HR Dept, ITS Dept, and LCCNR continue to meet to review and address solutions for payroll issues.

- 24) Case mix index has improved from .88 on June 3rd, 2022 to .93 on Sept 22, 2022. This will determine the Medicaid rate for Jan. 1st - June 30th 2023. We have until Sept 30th, 2022 to impact this and we anticipate this improving.

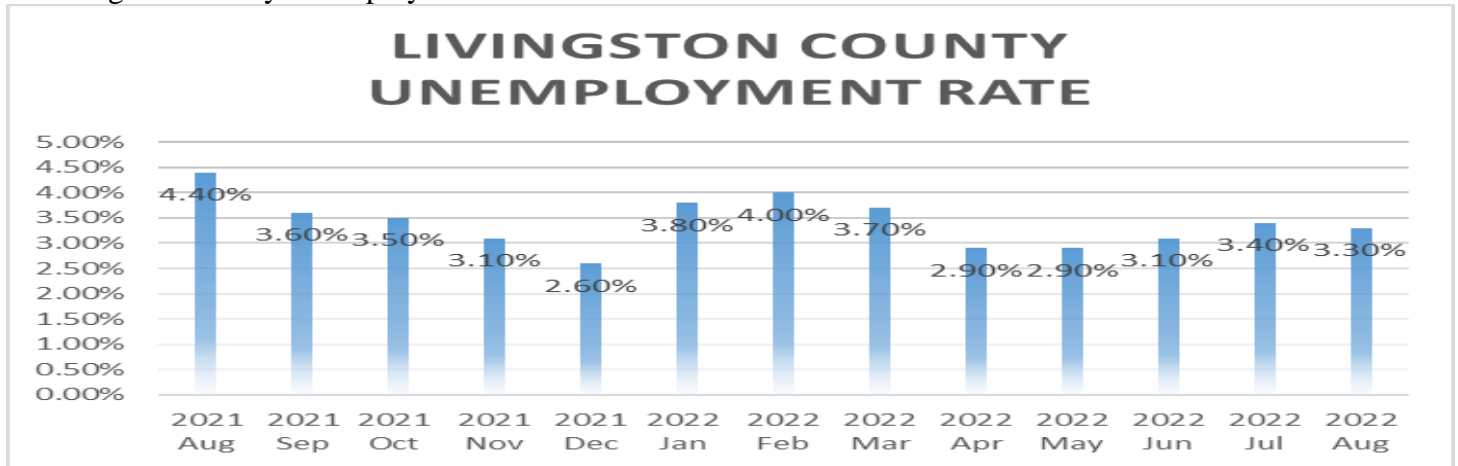

LCOFA subcontracts for free, unbiased counseling for Medicare beneficiaries. Lifespan provides help with Medicare plan choices, Medicare Savings Programs, Prescription Drug coverage options, and applying for Medicare. Call 585-498-4034.

Home Away from Home Respite Program:

In May 2022 we were informed that SUNY Geneseo would no longer take the lead for the Home Away from Home Program, employing the Program Coordinator. This program has been a highly successful collaboration between SUNY Geneseo, Noyes Hospital, and LCOFA; it started through a VISTA grant in 2015. SUNY Geneseo will still identify students to volunteer for the program. The Interfaith Center is still very interested in hosting the program and Livingston Cares has some funding for the site rental and materials. LCOFA will increase the funding for UR Med/Noyes Health and the Caregiver Coordinator will oversee the program. She has been involved since the beginning, and is the one who does the assessments prior to participants enrolling in the program. For approximately \$15,000, 10 individuals can participate in the program 2 times week for 4 hours during the school year, providing 240 hours of respite that caregivers need. In fact, this is the number one need expressed by caregivers. If we were paying for individual respite in the home, this service would cost close to \$72,000. **UPDATE: The program will kick off September 27, 2022.**

Falls Prevention Awareness Month

September is Falls Prevention Month and the National Council on Aging's Falls Prevention Week is the first full week of Fall – September 18th – 24th, 2022. Our Fall Prevention Event was held on September 16, 2022. It was the 7th annual (but not consecutive due to the pandemic) event. The event is a collaborative effort of many: LCOFA and Health Dept, Cornell Cooperative Extension, UR Med/Noyes Health and the Wilmot Cancer Institute, Genesee Valley Health Partnership and Wegmans. The event included vendors with fall prevention programs and resources, and 4 speakers (Paul Kreher, Physical Therapist, UR Med/Noyes Health, Kirsten Galliford, Wegman's Pharmacist, Lucille Tang, CCE Dietician, and Dr. Brooke Donaher, Optometrist). Car Fit appointments were offered (a program that maximizes driver safety for older adults). There was also a demonstration of Tai Chi, a fall prevention program. We continue to focus on fall prevention due to the negative impact of falls for the individual and for the community in terms of costs:

- More than one out of every four older adults falls each year.
- One out of every five falls causes an injury such as broken bones or head injuries
- More than 95% of hip fractures are caused by falling

Update: The event was attended by nearly 60 older adults and feedback was very positive:

- **98% of survey respondents indicated that they gained knowledge about the importance of fall prevention;**

- **95%** indicated that they definitely learned skills and strategies to prevent falls in the home; and
- **97%** indicated that they gained knowledge of local vendors and resources.

LCOFA is geared up for a very busy Fall with 5 Tai Chi for Arthritis classes, an Aging Mastery Class, and a yoga class. Update: **Over 100 older adults are signed up for classes.**
