WHEREAS, the hospice model involves an interdisciplinary, team-oriented approach to treatment, including expert medical care, quality symptom control, and comprehensive pain management as a foundation of care; and

WHEREAS, beyond providing physical treatment, hospice attends to patients' emotional, spiritual and family needs, and provides family services like respite care and bereavement counseling; ; and

WHEREAS, palliative care delivers expertise to improve quality of life and relief from pain, can be provided at any time during an illness, and hospices are some of the best providers of community-based palliative care; ; and

WHEREAS, in an increasingly fragmented and broken health care system, hospice is one of the few sectors that demonstrates how health care can, and should, work at its best for its patient; ; and

WHEREAS, 1.55 million Americans throughout the United States living with life-limiting illness, and their families, received care from the nation's hospice programs in communities; ; and

WHEREAS, hospice and palliative care organizations are advocates and educators about advance care planning helping individuals make decisions about the care they want; ; and

WHEREAS, the Centers for Medicare and Medicaid Services have pledged to put patients first in all of its programs, including hospice, ensuring a coordinated and patient-led approach to care, protecting patient choice and access to individualized services based on a patient's unique care needs and wishes; now, therefore, be it

**6. RESOLUTION CALLING ON THE GOVERNOR AND NEW YORK STATE LEGISLATIVE
LEADERS TO RESTORE REDUCTIONS TO COUNTIES SALES TAX**

WHEREAS, the County of Livingston has always been fiscally conscious; and

WHEREAS, the Covid-19 pandemic has put a fiscal burden on Livingston County, as well as the other 61 Counties; and

WHEREAS, sales tax revenue is an important and vital revenue for counties as said revenue assists in keeping property taxes at a minimum; and

WHEREAS, in 2019 and 2020, New York State diverted portions of the Livingston County-owned sales tax to make AIM payments to local towns and villages. In 2021, New York State intends to use these same County-owned sales tax dollars to pay not only the AIM payments to local municipalities but to also create a Distressed Hospital Fund. The annual impact to Livingston County of both planned diversions amounts to over \$800,000; and

WHEREAS, the loss of these revenues has caused significant fiscal stress and budget uncertainty for Livingston County while increasing pressure on property taxes; now, therefore, be it

RESOLVED, that the Livingston County Board of Supervisors calls upon Governor Cuomo and the New York State Legislature to put a stop to the diversion of Livingston County sales tax payments, both regular and internet sales tax, and return all diverted sales tax monies to Livingston County; and be it further

RESOLVED, that certified copies of this resolution be forwarded to Governor Andrew Cuomo, Senate Majority Leader Andrea Stewart-Cousins, Assembly Speaker Carl Heastie, Senators George M. Borrello and Patrick Gallivan, Assemblywoman Marjorie Byrnes and the New York State Association of Counties.
