### 2. County Administrator Updates:

- The 2021 Budget meeting schedule has started with department heads. The meetings have gone well. This is obviously a very challenging budget process this year and they are spending time zoning in on department expenses with time left to figure out the revenue situation with aid cuts and the sales tax impact. A part of that discussion is the stimulus package, which according to the news, looks to be dead for time being. There was talk of another stimulus package with local/state funding included from hundreds of millions to trillions of dollars nationwide. The County of Livingston was looking at millions in our allocation that is not in the cards right now. We are building the budget around that not being part of the equation.
- We did a bond refinancing that turned into ~\$250,000 in savings over the life of the bond. We had a pricing call this morning and we close in a couple of weeks.
- We are still waiting to hear on our USDA Reconnect Broadband application and should be hearing the status of that this month.
- Mr. Coyle recognized the Department of Health on their leading efforts to get the clinic testing site established in Mt. Morris for our local population. We are getting ~50 people per day.
- There was a meeting last Friday at their request with Wyoming County to discuss additional shared services opportunities and maybe build on the WIC and CNR Dialysis Extension Clinic partnership that we have.
- Mr. Davis reported on some dog calls made to several counties and that Livingston was the only county to answer the phones and/or call right back. He is very thankful that we have this kind of service.
