Bill Mann explained they are moving forward with the radio project in the County. The next step in the process is to secure another piece of property to build another tower in Portage. Mr. Mann responded that yes there are three areas where coverage is less than desirable. The tower is funded through the grant, there is no local share.

## PROVIDING FOR PUBLIC HEARING ON PROPOSED LOCAL LAW NO. D - 2018 - A LOCAL LAW AMENDING AND RESTATING LOCAL LAW NO. 4 OF THE YEAR 2016 RELATIVE TO THE LIVINGSTON COUNTY SELF-INSURANCE PLAN FOR WORKERS' COMPENSATION

WHEREAS, there has been duly presented and introduced at a meeting of this Board, held on September 12, 2018, a proposed Local Law entitled Local Law No. D- 2018 - A Local Law Amending and Restating Local Law No. 4 of the Year 2016 Relative to the Livingston County Self-Insurance Plan for Worker's Compensation; now, therefore be it

RESOLVED, that a public hearing shall be held on the said proposed Local Law by this Board on the 10th day of October, 2018 at 1:35 p.m. in the Board of Supervisors Assembly Room in the Livingston County Government Center in the Village of Geneseo, New York and at least six (6) days notice shall be given by posting thereof on the bulletin board of the Government Center in this County and by publishing such notice at least one (1) time in the official newspapers of the County as provided by law.

Mr. Coyle explained that this is relative to our self insurance plan for workers comp. A few years ago we did something similar. We amended our workers compensation law to include the participation of districts that didn't directly employee town or municipal workers. The Water and Sewer Authority plan to be their own employer 1/1/19; normally with being on their own they wouldn't be participating in the Comp plan that we have unless we make a similar change. We had our consultants review this and produce a quote that the Water and Sewer Authority is comfortable with. We don't see any major issues with having them participate.

Mr. Mahus expressed his concern with the volunteer firefighter cancer bill. He stated that the state has a promotion out but no plans on implementing it. He explained he thought they would be covered under the present volunteer fireman policy instead of having to go out on their own policy. Mr. Coyle responded that it is his understanding that the fire departments will eventually have to forecast that in their budget. stated he would look into it to see what information he can find.

## Pre-approved Informational Item(s) To Be Reported

2019 Budget Process- Mr. Coyle reported that he is done with Department Head budget meetings. Currently he has the sales tax number estimate inside the revenues and he is currently working on surplus/ deficit estimate for all of the departments for 2018. A dry run of the levy came in around 6%, they need to get it down to 3%. The numbers include New York state retirement that came in with a large budget surplus. Sales tax, health insurance trends and department submissions are helping. He stated he believes the final number will be around 3%.

- 2. Compensation Study Update Mr. Coyle reported that he received the latest draft back from The Burke group, which looks good. He stated he anticipates reviewing it at the next Ways and Means meeting.
- 3. Host Compliance Update Mr. Coyle explained they had a webinar last week regarding the issue of short term rentals. There is a potential compliance issue with respect to who is actually complying with the law. Currently, we have an honor system unless we get word of a complaint. We currently take in around \$190,000 in bed tax money every year, and this will help uphold the integrity of the law. If we get more people that aren't collecting and should be, under our existing agreement we will provide the tourism office with more revenue. We are looking into the company's software that would help track and manage short term rentals.
- 4. Town Tax Collection Program Mr. Coyle stated that the county had a program that was provided for tax collection purposes that is currently being phased out. Many towns are looking at the next step options. He explained that he is meeting with Town Clerks next week to figure out what to do next. He stated his concern is to make sure that the program that is chosen will work for all of the towns. He also said that he believes the county can help assist with the cost component of a new software program.

### **EXECUTIVE SESSION**

Motion made by Mr. LeFeber and seconded by Mr. Mahus that the Board adjourn and reconvene for the purpose of discussing the proposed acquisition, sale or lease of real property as publicity would substantially affect the value thereof; and All Supervisors, County Administrator Ian M. Coyle and Ashley Scutt remain present Carried.

Mr. Knapp moved and Mr. LeFeber seconded that the Committee reconvened in regular session. The following report was presented.

The Ways and Means Committee having met in Executive Session for the purpose of discussing the proposed acquisition, sale or lease of real property as publicity would substantially affect the value thereof; hereby reports as follow: No action taken.

Mr. Coyle added that they have received four applicants for the Director of Long Term Care position. He plans to set up an interview process, and committee, soon.
