**Action Item(s) To Be Reported**

**1. EXTENDING MILITARY LEAVE BENEFITS PROVIDED BY RESOLUTION 2001-427 AS SUBSEQUENTLY MODIFIED BY RESOLUTION 2014-342**

WHEREAS, Resolution 2001-427 was adopted in order to provide supplementary pay and continuation of benefits to eligible employees on military leaves; and

WHEREAS, said resolution was scheduled to expire on December 31, 2002 unless extended; and

WHEREAS, said resolution was extended through December 31, 2014; and

WHEREAS, the benefits provided by resolution 2001-427 were modified by resolution 2014-342 and the modified benefits were extended through December 31, 2018; and

WHEREAS, the Ways & Means Committee supports another extension; now, therefore, be it

RESOLVED, that the provisions of resolution 2001-427, as modified by resolution 2014-342 are hereby extended through December 31, 2020.

Ms. Lynn reviewed the historical resolutions that have been extended since 2001 and whether the Committee would like to continue the program. There was discussion on continuing the program permanently without having to renew. The Board will still have the ability to discontinue the program in the future if warranted. The program was originally put in place to address the 9/11 incident. Ms. Lynn reviewed military leave time frames. We may want to put some sort of cap or reporting requirement within the resolution in order to make payment. Ms. Lynn explained a particular situation where a then current employee joined the military and the County was unable to determine status due to lack of notification. The Committee would like to make the program permanent with a reporting requirement.

**2. ADOPTING THE LIVINGSTON COUNTY SEXUAL HARASSMENT POLICY AND THE LIVINGSTON COUNTY SEXUAL HARASSMENT PREVENTION POLICY NOTICE**

WHEREAS, Livingston County currently has a Sexual Harassment Policy previously modified by Resolution No. 2018-317 on September 26, 2018; and

WHEREAS, New York State adopted the final model Sexual Harassment Policy with some changes from the draft that were the basis of the most recently adopted Livingston County Sexual Harassment Policy; and

WHEREAS, New York State requires county sexual harassment policies to mirror the final state policy; now, therefore be it

RESOLVED, that the Livingston County Board of Supervisors hereby adopts the attached Livingston County Sexual Harassment Policy and the Livingston County Sexual Harassment Prevention Policy Notice, effective immediately, said policy to supersede the existing policy.

Ms. Lynn explained that the final modifications has now been made by the state. The policy notice and policy can now be adopted. There was discussion on adopting the model form so that there is never any question on compliance.

WHEREAS, the Director of Real Property Tax Services has attached ten (10) recommendations, applications and/or decisions (10 parcels) to correct the various tax rolls (Real Property Tax Law Sections 550 and 554), and

WHEREAS, the following corrections are hereby recommended for the 2019 tax rolls for the various towns in Livingston County, it is hereby

RESOLVED, that the Director of Real Property Tax Services is authorized to apply these corrections to the 2019 tax rolls,

**1. Town of Avon**

**Owner: Brian W. & Mallory W. Coyne**

**Tax Map Number: 25.-1-13.113**

Reason for correction: This parcel had an incorrect assessed valuation. The assessment shall be corrected from \$293,500 to \$225,000.

**2. Town of Avon**

**Owner: Avon Water Works**

**Tax Map Number: 44.-1-45**

Reason for correction: The investigation found that this parcel should have been wholly exempt. The exemption amount for this parcel was incorrectly shown as \$310,271 rather than \$319,813. For Town purposes

only, the taxable value shall be reduced to \$0.

**3. Town of Caledonia**

**Owner: Michael G. Mooney**

**Tax Map Number: 7.11-1-1.1**

Reason for correction: This parcel had an incorrect assessed valuation. The assessment shall be corrected from \$189,200 to \$123,100.

**4. Town of Conesus**

Reason for correction: This parcel had an incorrect assessed valuation. The assessment shall be corrected from \$125,000 to \$116,900.

RESOLVED, the Chairman of the Livingston County Board of Supervisors is hereby authorized to sign a contract clarification with retired Livingston County Administrator Dominic F. Mazza, subject to review by the County Attorney.

Mr. Coyle reviewed the 2009 agreement with now retired former Administrator Nick Mazza and how there have been changes to the offered health insurance coverage and particular plan type that is not really in existence any more. In the movement away from that an equal plan was developed under Excellus that is quite expensive. With Mr. Mazza and his wife now eligible for Medicare, the cost differences between continuing to

do the Blue Choice product versus what the County has at its disposal for this wraparound product plus Medicare is substantially less expensive for the County to provide. Discussions were held with the County Attorney and Mr. Mazza's attorney and a proposal was put together that speaks to this. Mr. Mazza and his wife will be going to a Medicare wraparound product that we call Medicare Blue Choice that we offer to our post 65 folks. By going to this product, and traditional Medicare, Mr. Mazza will be costing the County substantially less than he would have and, while he is not choosing to do so, technically he could have triggered the part of the agreement that says that he continue with the higher cost product. The County will be covering the costs of both Medicare and the wrap-around product and will be saving money while still properly honoring the agreement with Mazza. Mr. Coyle explained the changes in retiree health care obligations and the obligations until the early 1990s that were removed moving forward.

*Motion: Mr. LeFeber moved and Mr. Mahus seconded to approve the foregoing resolution .... Carried.*

## **5. REQUESTING THE STATE OF NEW YORK AND THE SENECA NATION COME TO AN AGREEMENT ON GAMING REVENUE SHARING**

WHEREAS, in 2002, the State of New York and the Seneca Nation entered into a compact with a provision that gaming revenue would be shared with the State in return for certain gaming exclusivity rights in Western New York; and

WHEREAS, as part of this legislation, the State of New York shares with local governments, including 16 counties in Western New York, a portion of the revenue they receive from the Seneca Nation; and

WHEREAS, the counties rely on that revenue to maintain infrastructure and provide public safety for all residents as well as provide services needed to help support this growing gaming industry; and

WHEREAS, in 2017 a dispute between the Seneca Nation and the State arose over the language within the compact, leading the Nation to stop revenue sharing payments to the State; and

WHEREAS, the Seneca Nation contends that its responsibility to pay local governments a share of the revenue ended in 2017 at which point the responsibility was transferred to the State; and

WHEREAS, this revenue loss amounts to approximately \$50 million annually to the 16 counties in Western New York; and

WHEREAS, due to a state-imposed property tax cap, counties are finding it increasingly difficult to maintain the critical local services residents demand and expect; and

WHEREAS, the Seneca Nation and the counties of New York have a long history of productive partnerships and respect, and the Nation leaders have recently expressed that they wish to continue this valued partnership with local governments; and

WHEREAS, the long-term viability of this region depends, in part, on all parties coming to an agreement on the involved issues; and

WHEREAS, the Seneca Nation and the State of New York have elected to resolve this issue through arbitration, a process which has already been delayed for over a year in procedures such as panel selection; and now therefore be it

RESOLVED, Livingston County calls on the State of New York and the Seneca Nation to immediately resolve their differences and reach an agreement to avoid catastrophic harm to public safety and public services; and be it further

RESOLVED, Livingston County calls on the State to make counties whole for past and current losses caused by this negotiation process and to the extent that such losses have been caused by the failure of the State to reach an agreement with the Seneca Nation over the continued payments of revenues to local government; and be it further

RESOLVED, that Livingston County shall forward copies of this resolution to Governor Andrew M. Cuomo, the New York State Legislature, and all others deemed necessary and proper.

Mr. Coyle reviewed the revenue that we no longer receive from being in an exclusivity zone. The County

Attorney modified the NYSAC model to call on them to make the counties whole.
