- SECTION 1. Effective as hereinafter provided, the annual salary of the Personnel Officer shall be increased by \$1,000.00.
- SECTION 2. Effective as hereinafter provided, the annual salary of one Commissioner of Elections shall be increased by \$475.00.
- SECTION 3. Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$1,800.00.
- SECTION 4. Effective as hereinafter provided, the annual salary of the County Superintendent of Highways shall be increased by \$1,450.00
- SECTION 5. Effective as hereinafter provided, the annual salary of the Director of Real Property Tax Services shall be increased by \$1,000.00.
- SECTION 6. Effective as hereinafter provided, the annual salary of the County Treasurer shall be increased by \$1,275.00.
- SECTION 7. Effective as hereinafter provided, the annual salary of the County Attorney shall be increased by \$1,125.00.
- SECTION 8. All salaries set forth herein shall be effective as of January 1, 1987.
- SECTION 9. This Local Law shall take effect on the date of filing in the office of the Secretary of State of the State of New York.
- SECTION 10. This Local Law is subject to permissive referendum.




