SECTION 1. It is the intention of the County of Livingston to offer an incentive to eligible employees to encourage them to retire, so as to reduce expenditures by the County of Livingston for salary and retirement benefits.

SECTION 2. Eligible employees shall be those nonelected employees of the County of Livingston currently listed on the Department Head Schedule who are currently eligible to receive benefits under the New York State Retirement System.

SECTION 3. The County of Livingston hereby establishes an early retirement incentive for all eligible employees as follows:

- a. An eligible employee with ten or more years and less than 20 years of Livingston County Service shall be provided, upon retirement, with a single plan health insurance policy as currently offered by the County of Livingston. If the plan being utilized by the retired eligible employee is no longer offered by the County of Livingston in future years, the retired eligible employee may select a single plan health insurance policy then being offered by the County of Livingston.
- b. An eligible employee with 20 or more years of Livingston County Service shall be provided, upon retirement, with a family plan health insurance policy as currently offered by the County of Livingston. If the plan being utilized by the retired eligible employee is no longer offered by the County of Livingston in future years, the retired eligible employee may select a family plan health insurance policy then being offered by the County of Livingston.
- c. Upon retirement, all eligible employees shall receive one week of pay, at their 1993 salary rate, for each full year of service with the County of Livingston. This additional incentive pay may be taken by the eligible employee in cash or may be applied to upgrade their health insurance policy.

SECTION 4. To be eligible for this early retirement incentive, the eligible employee must retire on or before July 31, 1993.

SECTION 5. This Local Law shall take effect upon filing with the Secretary of State.
