Section 1.

Section 3 of Local Law No. 2 – 1998 entitled “A Local Law Providing a Partial Exemption from Real Property Taxes to Persons with Disabilities who have Limited Income” is amended to read as follows:

Section 3.

To be eligible for the exemption authorized by Real Property Tax Law §459-c and implemented by this Local Law, the maximum income of such person shall not exceed \$15,500.00. Any such person having a higher income shall be eligible for an exemption in accordance with the following schedule:

<u>ANNUAL INCOME</u>	<u>PERCENTAGE ASSESSED VALUATION EXEMPT FROM TAXATION</u>
More than \$15,500.00 but less than \$16,500.00	45 per centum
\$16,500.00 or more but less than \$17,500.00	40 per centum
\$17,500.00 or more but less than \$18,500.00	35 per centum
\$18,500.00 or more but less than \$19,400.00	30 per centum
\$19,400.00 or more but less than \$20,300.00	25 per centum
\$20,300.00 or more but less than \$21,200.00	20 per centum
\$21,200.00 or more but less than \$22,100.00	15 per centum
\$22,100.00 or more but less than \$23,000.00	10 per centum
\$23,000.00 or more but less than \$23,900.00	5 per centum
