After presentation by Gregory J. McCaffrey, District Attorney, the Livingston County Grand Jury handed up indictments on the following individuals (along with 1 sealed indictment) on August 4, 2016.

**JASON A. KLINKBEIL**, age 28, of Livonia was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Impaired by Drugs (Misdemeanor), Driving While Impaired by Drugs and Alcohol (Misdemeanor), two counts of Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor), and Criminal Possession of a Hypodermic Instrument (Misdemeanor.)

**RENE M. FIGUEROA**, age 48, of Mt. Morris was charged with Attempted Gang Assault in the First Degree (C Felony) and Attempted Assault in the Second Degree (E Felony.)

**EDGARDO SANTIAGO**, age 36, of Mt. Morris was charged with Attempted Gang Assault in the First Degree (C Felony) and Attempted Assault in the Second Degree (E Felony.)

**ERICK A. SANTIAGO**, age 33, of Geneseo was charged with Attempted Gang Assault in the First Degree (C Felony) and Attempted Assault in the Second Degree (E Felony.)

**LAURINA M. DOW**, age 37, of Wayland was charged with Robbery in the First Degree (B Felony), two counts of Robbery in the Second Degree (C Felony), Assault in the Second Degree (D Felony), Grand Larceny in the Fourth Degree (E Felony), and Tampering with Physical Evidence (E Felony.)

**DANIEL D. TREWER**, age 40, of Wayland was charged with Robbery in the First Degree (B Felony), two counts of Robbery in the Second Degree (C Felony), Assault in the Second Degree (D Felony), Grand Larceny in the Fourth Degree (E Felony), and Tampering with Physical Evidence (E Felony.)

**GREGORY K. WALSH**, age 25, of Livonia was charged with Vehicular Assault in the First Degree (D Felony), Assault in the Second Degree (D Felony), two counts of Driving While Impaired by Drugs (Misdemeanor), and Failure to Maintain Lane.

**ANN MARIE BOUDREAU**, age 29, of Rochester was charged with Burglary in the First Degree (B Felony), Criminal Possession of a Weapon in the Third Degree (D Felony), Menacing in the Second Degree (Misdemeanor), Petit Larceny (Misdemeanor), and Criminal Possession of a Hypodermic Instrument (Misdemeanor.)

**DELDRICK L. HOLLOWAY**, age 37, of Elmira was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Falsifying Business Records in the First Degree (E Felony), Criminal Impersonation in the Second Degree (Misdemeanor), and Unauthorized Sticker or Poster on Vehicle.
