<b>Abstract</b>	The collection comprises records created by and pertaining to the Dansville and Mt. Morris Railroad Company based in Dansville, Livingston County, New York from 1891 to 1984. The records span the lifetime of the company and are composed of financial ledgers and accounting, payroll and tax documents, freight and shipping papers, quarterly, monthly, and annual reports, legal proceedings, maps and surveys, stockholders' papers, and other miscellaneous materials.

## II. Background Information

When it began in 1868, the Dansville and Mt. Morris Railroad Company (DMM) was known as the Erie & Genesee Valley Railroad Company. The initial plan was to construct a line connecting Burns, NY, to Rochester via the Erie Railroad, with a track running between Dansville and Mt. Morris. The latter connection was completed with financial assistance from the Erie in 1871, though the line between Burns and Dansville was never built. The Erie leased the 15-mile long Dansville to Mt. Morris line for the next 20 years.

After reorganization in 1891, the line became independent from the Erie under the new name the Dansville & Mount Morris Railway Company. It still only connected with other rail lines at Mt. Morris, so soon endeavored to make contact with the Delaware, Lackawanna & Western (DL&W) at Groveland, and the Western New York & Pennsylvania (WNY&P, later the Pennsylvania Railroad (PRR)) at Mount Morris. Only the latter was initially successful because of tensions between the Erie and DL&W. In 1933, however, there was pressure from the Foster-Wheeler Company for better connectivity in the region. Despite the Erie's protests, and at the order of the Interstate Commerce Commission (ICC), the link at Groveland Station with the DL&W was made. A few years later, the Erie claimed this union resulted in less traffic on the section between Avon and Mt. Morris, and in 1940 abandoned this part of their track.

Between 1939 and 1943, the DMM also greatly reduced services and tracks. First the passenger service was discontinued, and in 1940 the DMM removed its three-mile line Mount Morris and Sonyea. Three years later, the original line between Groveland and Sonyea, a length of four miles, was also ripped up. All that remained was a 7.8-mile route between Groveland and Dansville, making the DMM about half as extensive as it had been.

In 1960, the Erie and the DL&W merged, forming the Erie Lackawanna (EL). The next mainline to be removed was the DL&W service, running between Wayland and Groveland, in 1963. The same year, the DMM constructed a new engine house in Dansville; by this time, engines ran on diesel instead of steam.

In April of 1976, EL was absorbed into Conrail; just a few years later, in 1982, the section of track between Greigsville and Groveland became the jurisdiction of the Genesee & Wyoming (G&W). DMM continued to hold contact with other lines only at Groveland.

On July 23, 1985, 94 years after its formation as an independent railroad, the DMM was acquired by the G&W. The following year, the DMM's two remaining engines were purchased by the Bay Colony railroad of Massachusetts. The G&W, too, lost its independence when it was absorbed by the Rochester & Southern network.

For years, Foster Wheeler Corp. was the only customer of the old DMM line, and its sporadic movements were hardly enough to keep the line in operation. When the company closed in 2003, the DMM tracks were in peril. By 2006, however, American Motive Power (AMP) had located in the former Foster-Wheeler factory, and while it remains the only customer south of Mt. Morris, this section of rail service is still in use.

The collection was donated to the Livingston County Historian's Office in 2011 by Robert F. "Bob" Hart of Dansville. Robert's father, Frank A. Hart, accepted a position with DMM in 1920 as a freight agent, and as general manager after 1934. Bob joined the company in 1941 while still in university, and eventually became President and General Manager of DMM as his father had been. Before Bob passed away in 2012, he donated the records stored in the old depot in Dansville, which served as his office and the repository for the DMM's history. As of February 2015, the depot still stands but needs work and has not been repurposed.
