

Livingston County Environmental Management Council 2019 Earth Day Award

Purpose

To recognize outstanding achievements that are directed to help preserve, improve, or educate about the Livingston County Environment.

Eligibility

Any individual, group, business, or agency is eligible. While the recipient does not need to reside in the County, the actions and achievements on which the nomination is based must have occurred partially or wholly in Livingston County.

Criteria

- The recognized work must be a contribution or achievement in preserving, improving, or educating about the natural environment of the County.
- The degree of creativity of the nominee will be considered.
- Documentation is necessary to allow for the measurement of the achievement(s).
- The achievement(s) may have occurred during the previous year, or may have been on-going over a number of years, and must be noted in the nomination.

Selection Process

A committee from the Livingston County Environmental Management Council (EMC) is appointed by the Chairman each year to review nominations and to present recommendations to the entire EMC membership. The award recipient is then notified, and the award is presented at a Livingston County Board of Supervisors meeting in April or May.
