

Registration by Mail: Forms for registration by mail may be obtained at the following offices: Board of Elections, Town Clerk, Village Clerk, Chamber of Commerce, Dept. of Motor Vehicles and other State Agencies providing services to the public.

Absentee Voting: Civilians may qualify to vote by absentee ballot if their duties, occupation, or business requires them to be away from their county of residence, or if they are on vacation on the day of any village election. (Including spouse, parent or child accompanying such person).

Applications for absentee ballots to be mailed to the voter must be received by the Board of Elections not later than seven days before the election. If the applicant or his agent delivers the application to the Board of Elections in person, such application must be received not later than the day before the election. All absentee ballot envelopes must be postmarked no later than the day before the election.

Important Dates

Jan 2	First day to sign independent nominating petitions.	Mar. 8	Last day for voter to register with Board of Elections to vote in village election.
Jan. 8-15	First day to publish party caucus notice in newspaper. (not earlier than 2 weeks prior to caucus depending on date of caucus)	Mar. 13	Last day for Board of Elections to receive application for an absentee ballot to be mailed to a voter.
Jan.14-22	Last date to post and file in office of village clerk AND the Board of Elections, notice of party caucus, depending on date of caucus. (At least 10 days before caucus). Last day to post notice of party caucus in six (6) public places depending on date of caucus. (At least 10 days before caucus required only if you have published the notice).	Mar. 18	Last day for applicant or applicant's agent to personally deliver application for an absentee ballot to the Board of Elections.
Jan. 22-29	Dates for holding party caucus. Note: Party officials must either (a) publish notice of caucus in newspaper not more than two (2) nor less than one (1) week before the caucus, OR (b) post notice of the caucus in six (6) public places in the village at least ten (10) days before caucus. Notices must also be filed and posted in the offices of the village clerk and county board of elections at least 10 days before the caucus.	Mar. 19	Election Day. Polls open Noon to 9 PM.
Jan. 24-31	Dates for filing certificate of party nomination.	Mar. 26	Last day for Board of Elections to complete canvass of village elections conducted by the Board of Elections.
Feb. 4	Last day to file certificate of acceptance or declination of party nomination.	Apr. 15	Financial Disclosure Statements due.
Feb. 5-13	Dates for filing independent nominating petitions.	Offices to be filled:
